

INTRODUCTION

SECURITY POLICIES OF OUR WEBSITE AND USER INFORMATION

This page describes the website's management methods, with particular reference to the handling of the personal data of users visiting it.

Data provided voluntarily by the user

The optional, explicit and voluntary sending of electronic mail to the addresses indicated on this website involves the subsequent acquisition of the sender's address, which is necessary to respond to requests, as well as any other personal data included in the message.

The processing to which the personal data referred to above will be subjected has the sole purpose of allowing our Company, the Data Controller, to answer questions, queries, requests for clarification, or to accept the suggestions of users.

The data will not be disseminated and may be known by collaborators of our Company specifically authorised to process them, as Data Processors or agents.

The Privacy Rules (Art. 15-22 of the Regulations) grants you the right to access at any time the data concerning you, as well as their correction and/or completion, if inaccurate or incomplete, their erasure or the restriction of their processing, if the conditions are met, to the objection to their processing for reasons connected to your particular situation, to the portability of the data supplied by you, where processed in an automated way for the contractual services you requested, within the limits of the provisions of the Regulation (Article 20).

The Data Controller is A3G srl based in **S.Vito al Tagliamento** . You can contact the Data Protection Officer both to exercise your rights and to get information on the updated list of categories of Data Recipients. Your right to lodge a complaint with the Italian Data Protection Authority, (il Garante Privacy), when you consider it necessary for the protection of your personal data and your rights in this matter, remains unaffected.

Specific summary information will be progressively shown or displayed on the website pages dedicated to particular on-demand services.

The user is free to provide personal data contained in the application forms or indicated in contacts with the corporate office to request the sending of information materials or other communications. Failure to provide this data may make it impossible to obtain the requested service.

Web Browsing Data

During their normal operation, computer systems and software procedures used to operate this website acquire some personal data, the transmission of which is implicit in the use of internet communication protocols. This is information that is not collected in order to associate it with identified individuals but which by its very nature could allow, through processing and association with data held by third parties, users to be identified. This category of data includes IP addresses or

domain names of computers used by persons who connect to the site, the URI (Uniform Resource Identifier) of requested resources, the time of request, the method used to submit the request to the server, the size of the file received in reply, the numerical code indicating the status of the reply provided by the server (successful, error, etc.) and other parameters regarding the user's operating system and computer environment. This data is used only to obtain anonymous statistical information about website usage and to check its correct functioning; it is deleted immediately after processing. The data could be used to ascertain responsibility in the event of suspected computer crimes.

Processing methods

The personal data is processed with automated tools for the time strictly necessary to achieve the purposes for which it was collected.

In order to prevent data loss, illicit, or incorrect use of data and unauthorised access, specific security measures are implemented.

PRIVACY POLICIES

Our Company processes the personal data of third parties - actual and potential clients, as well as collaborators, - always adopting every measure necessary to guarantee the confidentiality and security of the data processed.

In application of the current legislation on the protection of personal data, we are organised as follows:

The Data Controller of personal data is A3G srl with its registered office in S.Vito al Tagliamento , who has named Barbin Matteo as Data Protection Officer for the application of the privacy policy in the Company;

In order to guarantee compliance with the regulations and the instructions given on privacy, specific Process Owners have been identified for the various processes carried out within the internal organisational structure;

The Company only acquires the personal data strictly necessary for the performance of the services requested or for the purposes for which specific information is collected;

In order to guarantee the exercise of the rights provided for by Articles 15-22 of the Regulations (access to information and other rights) and to provide any further information regarding the protection of personal data, each Data Subject may approach the Data Protection Officer by contacting:

obtain information on persons who may become aware of them as Data Processors or agents, also as a result of activities performed by other Group companies on the basis of service contracts;
request the portability of the data supplied by the Data Subject, where processed in an automated manner for the contractual services requested, within the limits of the provisions of the Regulation (Article 20).

MONITORING AND STATISTICS: (Use of Google Analytics)
